

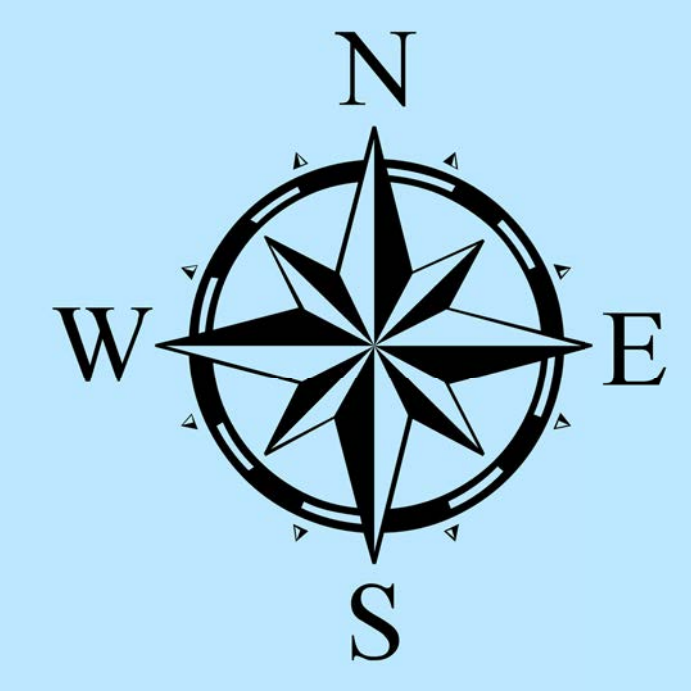

The Board of County Commissions (2026) is divided into eight County Precinct Districts within Orange County, Board of County Commission districts 1, 2, 3, 4, 5, 6, 7 and 8.

County Commission (2026) district 1. The northern boundary runs along the southern shore of Lake Apopka and continues east just north Juniper Hammock St up to SR-429. The northern boundary continues on SR-429 south and travels east along Roberson Road and Park Ridge Gotha Road, up to I-91. The western boundary follows along the Lake/Orange County border. The southern border follows along the Osceola/Orange County border and extends to I-4. The eastern boundary is Turkey Lake Road, I-4 and I-91.

County Commission (2026) district 2. The northern boundary follows the Orange/Lake County border. The western boundary also follows the Orange/Lake County border, until the northern shore of Lake Apopka. The western boundary continues along Lake Apopka until it reaches SR-429. District 2 continues on SR-429 until it reaches Roberson Road. The southern boundary is a combination of Roberson Road, Park Ridge Gotha Road, I-91, SR-408 and Old Winter Garden Road. The eastern boundary is a combination of the Orange/Seminole County border and various roads, Good Homes Road, N Apopka Vineland Road, Clarcona Ocoee Road, Edgewater Drive, W Kennedy Boulevard and just east of Forest City Road.

County Commission (2026) district 3. The northern boundary is E Colonial Drive. The southern boundary follows Central Florida Park Way, OUC RR and Heintzelman Boulevard. The eastern boundary is Heintzelman Boulevard and Goldenrod Road. The western boundary has multiple roads, N Magnolia Avenue, S Orange Avenue, S Rosalind Avenue, Holden Avenue, S Orange Blossom Trail, SR-528 and S John Young Parkway,

County Commission (2026) district 4. The northern boundary follows Colonial Drive, Little Econlockhatchee Tributary River, Rouse Road and J Blanchard Trail. The western boundary follows Goldenrod Road. The southern boundary is SR-528. The eastern boundary follows Econlockhatchee River.

County Commission (2026) district 5. The northern boundary follows the Orange/Seminole County border. The western boundary has a road combination of Temple Trail, southern shore of Lake Maitland, Sunnyside Drive, Monroe Avenue, I-4, Clay Street, N Orange Avenue and N Magnolia Avenue. The western boundary continues on E Colonial Drive until it reaches Econlockhatchee River. The southern boundary follows Orange/Osceola County boarder. The eastern boundary follows the Orange/Brevard County border and Orange/Seminole County border.

County Commission (2026) district 6. The northern boundary is a combination of W Colonial Drive, Old Winter Garden Road, Carter Street, S Hiawassee Road, southeast shore of Lake Hiawassee and Steer Lake Road. The western boundary follows along I-91, Turkey Lake Road and I-4. The southern boundary follows along SR-528. The eastern boundary follows along South Orange Blossom Trail, Holden Ave, Orange Avenue and N Magnolia Ave.

County Commission (2026) district 7. The northern boundary is a combination of Orange/Seminole County border, east of Forest City Road, W Kennedy Boulevard, Clarcona Ocoee Road and Beggs Road. The western boundary is N Apopka Vineland Road, east of Lake Stanley, Good Homes Road, Gotha Road, west of Lake Rose and Steer Lake. The southern boundary consist of Steer Lake Road, southeast shore of Lake Hiawassee, S Hiawassee Road, north of Charter Lake, Old Winter Garden Road and W Colonial Drive.



County Commission (2026) district 8. The southern border follows along the Osceola/Orange County border. The western boundary runs along I-4. The northern boundary is a combination of SR-528, Central Florida Parkway, OUC RR, Boggy Creek Road and Heintzelman Boulevard. The eastern boundary is Econlockhatchee River.
