<b>APOPKA</b> 407-703-1704	32 square ft. maximum size.	Not to exceed 6 square ft. per face.	Shall not place any political sign on any public property or right-of-way nor on any private property without the express permission of the owner or as may be allowed at public polls. <b>BELLE ISLE</b> 407-851-7730	Nonilluminated and shall not exceed 32 square ft. No larger than 4 square ft. in area or located within 40 ft of any other sign. Any sign larger than 4ft shall be approved by City Manager prior to installation.	2 nonilluminated, not more than 4ft in height, no more than 4sqft in area. May be installed with express consent of occupant or owner of vacant property.	Campaign signs shall not be placed on public property- will be removed by city officer.	May not be erected more than 90 days before date of election. Signs shall be removed 48 hours after the close of the election.
<b>EATONVILLE</b> 407-623-8900	Must not exceed 10 square ft in area and 6 ft in height. Must be unlit.	Must not exceed 10 square ft in area and 6 ft in height. Must be unlit. Must have consent of the owner or occupant of property.	All signs placed in the public right-of-way or on town property shall be subject to immediate removal and disposal by the town. Must not be on public property or utility polls.	30 days prior to 10 days after election.
<b>EDGEWOOD</b> 407-851-2920	Three temporary signs no greater than six square ft. each in copy area up to three feet in height. Temporary signs must be at least 5 ft. from any right-of-way and at least 10 ft from the side and rear property lines	One temporary freestanding signs no greater than 6 square ft. in copy area with sign height no greater than 3 ft shall be allowed on the premises at any time.	Signs shall not be illuminated. Temporary signs shall be repaired or removed immediately if they become faded, worn, broken, decayed, or otherwise fall into poor repair.	Beginning 60 days prior to any local, state, or federal election and lasting until three days after such election.
<b>MAITLAND</b> 407-539-6219	Shall not exceed six (6) square feet in sign area and shall not exceed four (4) feet in height as measured from the grade.	Shall not exceed six (6) square feet in sign area and shall not exceed four (4) feet in height as measured from the grade.	Signs are not subject to permits or fees. For each parcel, a maximum of three (3) campaign signs may be displayed per street frontage but <b>shall not be placed in the right-of-way.</b>	60 days prior and removed within seven (7) calendar days following the election to which it pertains.
<b>OAKLAND</b> 407-656-1117	32 square ft. maximum size, per parcel, per endorsed candidate.	16 square ft. maximum size, per parcel, per endorsed candidate. Permitted with written permission from the affected property owner.	8 ft. maximum height. Political signs shall not be placed on any public property or public right-of-way or on private property without owner's written permission.	60 days prior to election and 7 days after election.

<b>ORANGE COUNTY</b> 407-836-3111	32 square ft. maximum size per parcel.	16 square ft. maximum size per lot. Signs may be erected in residential districts only with the written permission of the landowner.	Maximum height of any political sign is 8 ft. Signs may be permitted in all zoning districts.	90 days prior to 10 days after election.
<b>ORLANDO</b> 407-246-2686	Owner permission required. Up to two signs per lot, each no larger than 12 sq. ft. and 6 ft. tall.	Up to three minor signs allowed, each no larger than 4 sq. ft. and no taller than 6 ft.	Permits may be required. Signs are not allowed on public property or within the right-of-way. For additional information, refer to Section 64.323 of the Orlando City Code.	Removed within 180 days. Unauthorized signs on public property or in the right-of-way may be removed immediately.
<b>WINDERMERE</b> 407-876-2563	Political and election campaign signs not exceeding 4 square ft in area may be displayed by an owner or tenant on their property without a permit. <b>WINTER GARDEN</b> 407-656-4111	32 square ft. maximum size.	8 square ft. maximum size.	City Code Board may assess fines for each sign not removed within 30 days. Campaign signs not permitted on public property.	Remove within 30 days after election.
<b>WINTER PARK</b> 407-599-3600	Shall not individually exceed four square feet in area nor six feet in height. One sign on any one property frontage, per street frontage.	No more than two signs per street frontage and only one per candidate. 4 square ft. maximum size.	Signs shall be located only on private property with express permission of property owner or occupant. Must be located behind sidewalk or 10 ft. behind curb or edge, whichever is greater. No signs on public right-of-way	Remove within 7 days of election.
